## Rapport de l'auditeur indépendant

À l'intention des administrateurs de

Nous avons effectué l'audit des paiements associés au code de pays CAN de Rio Tinto Canada Inc., Compagnie Minière IOC Inc., Rio Tinto Fer et Titane Inc., Rio Tinto Diamond and Mineral Canada Holding Inc. et Diavik Diamond Mines 2012 Inc. (les « Sociétés ») inclus dans le tableau joint « Government Payments by Type » totalisant 3 856 357 180 \$ US, ainsi que dans le tableau joint « Project Payments by Type » totalisant 3 856 357 180 \$ US de Rio Tinto PLC pour l'exercice terminé le 31 décembre 2017 (les « Paiements »). Les Paiements ont été préparés par la direction conformément aux exigences énoncées dans *The Reports on Payments to Governments Regulations 2014* du *European Communities Act* (le « Référentiel d'information financière »).

### **Responsabilité de la direction pour les Paiements**

La direction des Sociétés est responsable de la préparation des Paiements conformément au Référentiel d'information financière, ainsi que du contrôle interne qu'elle considère comme nécessaire pour permettre la préparation des Paiements exempts d'anomalies significatives, que celles-ci résultent de fraudes ou d'erreurs.

### **Responsabilité de l'auditeur**

Notre responsabilité consiste à exprimer une opinion sur les Paiements, sur la base de notre audit. Nous avons effectué notre audit selon les normes d'audit généralement reconnues du Canada. Ces normes requièrent que nous nous conformions aux règles de déontologie et que nous planifions et réalisions l'audit de façon à obtenir l'assurance raisonnable que les Paiements ne comportent pas d'anomalies significatives.

Un audit implique la mise en œuvre de procédures en vue de recueillir des éléments probants concernant les montants et les informations fournis dans les Paiements. **Opinion**
