Diavik Diamond Mines Community Contribution Fund

DDMI's Community Contribution program is aimed at serving and strengthening the communities of the Northwest Territories and West Kitikmeot, and creating a better quality of life for community members and/or community organizations.

The DDMI Community Contribution Fund assists community based non-profit organizations with projects that align with DDMI's priority areas, including:

- 1. Business Capacity Building (Business and educational development)
- 2. Health, safety, and wellness
- 3. Culture, arts, and community pride

Eligibility for DDMI Community Contribution Fund

- Community/organization must be located in the Northwest Territories or West Kitikmeot region
- Priority will be given to applications stemming from organizations in communities which DDMI has key business relationships, or are impacted by the DDMI operation (Dettah, N'dilo, Behchoko, Gameti, Whati, Wekweeti, Lutsel K'e, Kugluktuk, Cambridge Bay, Yellowknife, Hay River, and Fort Smith)
- Preference will be given to designated or registered charitable and non-profit organizations

DDMI will not provide funding for:

- organizations that are directly involved in gambling, recreational or illegal drugs, tobacco, firearms or alcohol (with the exception of those charities and organizations specifically dedicated to tackling addiction or drug abuse);
- oraganizations that have policies or practices that discriminate unfairly on grounds of race, creed, sexual orientation, religion, gender, disability or age;
- initiatives that cause harm to wildlife, and or damage to the environment;
- religious organizations, individuals, political organizations and candidates;
- initiatives outside of the NWT or West Kitikmeot: and
- initiatives where funds directly cover travel related expenses.

Application Period

- Applications will be accepted throughout the year.
- Applications must be received prior to the start of the project/program.
